No. S.O. 53/H.G.S.T.R. 1975/R-21/2002. – Whereas it has been reported by the Deputy Excise & Taxation Commissioners, Bhiwani, Gurgaon (W), Hisar, Jagadhari, Kaithal, Kurukshetra, Karnal, Rewari, Rohtak and Sonipat that the declarations in form ST-14 and ST-15 as specified in the Schedule given below have been lost;

Now, therefore, in exercise of the powers conferred by the sub-rule (15) of rule 21 of the Haryana General Sales Tax Rule, 1975, the Government of Haryana hereby declares the serial numbers of the declarations in form ST 14 and ST 15 mentioned in the Schedule given below as obsolete and invalid with effect from the date mentioned against each. Any one fraudulently using the said forms shall render himself liable to penal action in accordance with provisions of Haryana General Sales Tax Act, 1973 (Haryana Act 20 of 1973), and the rules framed thereunder:-
