NOTICE FOR INVITING TENDERS FOR ALLOTMENT OF RETAIL LIQUOR LICENSES OF COUNTRY LIQUOR (L-14A) AND IMFL (L-2) FROM THE GENERAL PUBLIC FOR THE YEAR 2009-10 IN THE STATE OF HARYANA.

It is notified for the information of general public that TENDER applications for allotment of retail outlets of Country Liquor and IMFL have been invited in the State of Haryana for the year 2009-10 as below:-

1. The applications shall be entertained in the prescribed format only which is available in all the offices of the Deputy Excise and Taxation Commissioners (Excise) in the State, on Department Website i.e. www.haryanatax.com and also given hereunder. (This form can also be used to submit the bid).
2. Each TENDER Form shall be accompanied with Participation Fee of Rs.10,000/- (non refundable and non adjustable) preferably in the form of bank draft payable in favour of "DETC(Excise)".
3. Each TENDER Form shall also accompany bank draft payable in favour of the DETC(Excise) for earnest money to be calculated for the retail liquor outlet applied for considering the reserve price of the retail outlet as per clause 4 below. The earnest money draft be separately submitted and should be outside the sealed bid envelope.
4. The earnest money to be deposited with the TENDER Form will be calculated as below:-

For vends with reserve price:

(Note:- Earnest Money DD be given separately & **not in** bid envelope.)

5. The TENDER Forms are required to be furnished separately in sealed envelope for each retail outlet. A bidder can apply for any number of vend(s) of any District and the State.
6. The persons applying for allotment of liquor vends against reserved category shall have to submit necessary caste certificate i.e. SC or BC(A) issued by the competent authority of the Haryana Government failing which their tenders are liable to be rejected.
7. The vend(s) shall be allotted to the highest eligible tenderer quoting equal to or above the reserve price of the vend(s). In case of more than one bid quoting the same highest price is received, the allottee shall be determined by draw of lot among the tenderers quoting the same highest price.
8. The list of vends having details of vend name, vend code, location, command area if applicable, reserve price, quota and category [i.e. general, SC or BC(A)] are available in the office of the DETC(X) of the district as well as on the department website.
9. The bid shall be submitted on or before the last date and time prescribed in a sealed envelop containing only the financial bid in the prescribed format completed in all respect.
10. The bid amount shall be in multiple of Rs.10,000 /- only. In case the bid amount is not in multiple of Rs.10,000/-, it will be upgraded to next multiple of Rs.10,000/- and treated as such for the bid.
11. The bidder shall clearly indicate in the tender form the category for which applied for i.e. General, SC or BC(A) category. A label as given below will be affixed on the bid envelope for identification purposes.
12. All tenders received upto the last prescribed date shall be opened in the presence of the tenderers by a committee consisting of the Deputy Commissioner, DETC(ST) and DETC(X) of the concerned district and the result thereof shall be announced on the spot.

13. The list of tenders received shall be displayed in the office of the DETC(X) concerned one day before the day of opening of tenders.
14. All licenses shall be granted subject to the Excise Policy for the year 2009-10 and the Punjab Excise Act, 1914 (as applicable to the State of Haryana) and the rules framed thereunder.
15. All allotments shall be subject to the approval of the Excise and Taxation Commissioner, Haryana. He may reject, without assigning any reason, any allotment in public interest as the case may be within 10 days of the date of allotment.
16. The successful bidder/allottee shall be required to deposit a security amount equal to 20% of the annual licence fee of the vend, out of which 5% has to be deposited on the day of allotment/opening of tender, 5% within 7 days of the allotment or on or before 31st March, 2009 whichever is earlier and 10% by 7th of April, 2009. In the case of companies total annual licence fee shall be paid on the day of allotment/opening of tenders. No interest shall be payable on this security amount.
17. All successful allottees, before the start of operation of vend, shall be required to file prescribed documents including an affidavit on a non-judicial stamp paper of prescribed value to the effect that he has not been convicted of any non-bailable offence by a criminal court or of any offence under the Punjab Excise Act, 1948, the East Punjab Molasses (Control) Act, 1948, the Indian Power Alcohol Act, 1948 applicable to Haryana or the Narcotic Drugs and Psychotropic Substances Act, 1985. The successful allottee shall also file an affidavit before opening of the licensed outlets to the effect that he is not a defaulter and has paid all past dues of excise revenue in Haryana.
18. The tender form in the prescribed format alongwith the participation fee and earnest money preferably by bank draft, per application, per licensed outlet alongwith supporting documents, wherever required,

must reach the office of the DETC(X) of the respective district as per schedule given below:-

- (i) (a) Date of receipt of Tender Forms in the districts of Gurgaon, Narnaul, Panipat, Jagadhri, Mewat, Jhajjar, & Jind : 2nd to 5th March, 2009 from 10.00 A.M. to 5.00 P.M.
- (b) Date of opening of Tender Forms : 7th March, 2009 at 9.00 A.M.
- (ii) (a) Date of receipt of Tender Forms in the districts of Faridabad, Rewari, Sonipat, Kaithal, Hisar, Sirsa & Ambala : 9th to 14th March, 2009 (Except Holi i.e. 11.03.2009) from 10.00 A.M. to 5.00 P.M.
- (b) Date of opening of Tender Forms : 16th March, 2009 at 9.00 A.M.
- (iii) (a) Date of receipt of Tender Forms in the districts of Fatehabad, Bhiwani, Panchkula, Kurukshetra, Karnal & Rohtak : 13th to 18th March, 2009 (Except Sunday i.e. 15.03.2009) from 10.00 A.M. to 5.00 P.M.
- (b) Date of opening of Tender Forms : 20th March, 2009 at 9.00 A.M.

(On last day, in each district, all in queue at 5.00 P.M. will be given chits to ensure the submission of bid by DETC(X)).

- 19. Entire process of bid submission and tender opening shall be video-graphed.
- 20. Each person submitting a tender form would be issued a receipt in token thereof by the DETC(X) of the concerned district. This receipt would entitle the tenderer entry into the hall where the tenders will be opened by the prescribed Committee in the presence of the tenderers.
