

# **PUBLIC NOTICE**

## **EXCISE AND TAXATION COMMISSIONER, GOVERNMENT OF HARYANA, S.C.O. 71 TO 75, SECTOR-17C, CHANDIGARH.**

It is notified for the information of general public that for the year 2009-10, 10% and 5% of the retail country liquor and IMFL vends in each district of the State have been reserved for Scheduled Castes and Backward Classes (Category 'A' only) respectively.
